

## **Privacy Notice**

This privacy policy sets out how Wessex Diagnostic Ltd uses and protects any information that you give Wessex Diagnostic Ltd when you register for a training course.

Wessex Diagnostic Ltd is committed to ensuring that your privacy is protected and will only process it for legitimate interests that you would reasonably expect and which have minimal impact on your privacy.

This policy is effective from 01/01/2018 and Wessex Diagnostic Ltd will ensure this policy is regularly monitored and updated.

## **What we collect**

We may collect the following information by web form, email, phone or paper form:

- name and job title
- contact information including address, phone number and email address
- other information relating to course service provision, eg: dietary requirements
- feedback from the training courses
- credit card details where required for payment\*

## **What we do with the information we gather**

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
- Providing a Wessex Diagnostic regular newsletter
- Successful course payment
- Using feedback to improve our training courses

## **Security**

Any credit/debit card details are destroyed on successful payment of the registration. To encourage maximum security we recommend the payment method to be bank transfer.

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

Data will be stored for the minimum amount of time possible allowing for audits maximum of 15 years.

## **Data Sharing**

Data is only shared via delegate lists with the specific course partners, for your course only, to improve your experience of the practical scanning workshops.

Wessex Diagnostic Ltd will not sell, distribute or lease your personal information to third parties unless are required by law to do so.

## **How we use cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
